The Department of Social Development hereby calls for proposals from registered NPOs, CBOs and FBOs providing Social Developmental Services in the 5 districts of the Free State Province. The call for proposals is for a period not exceeding one year. This means that qualifying NPO's will enter into contract with the Department for a period of 12 months (2015/16).

- Services to Children and Families
- Girl-Child – Empowerment Programmes
- Women Development – Capacity Building Programmes
- Victim Empowerment Services including Men and Boys Programmes

- Programmes for Perpetrators of Domestic Violence
- Substance Abuse Programmes
- Services to Older Persons
- Services to persons and communities affected by HIV & AIDS
- Services to Children in conflict with the law and Adult Offenders
- Residential Substance Abuse Treatment Services to Children in Conflict with the Law
- Partial Care Facilities / Early Childhood Development Programme
- ECD Mobile Services
- Regional Training Organisations (ECD)
